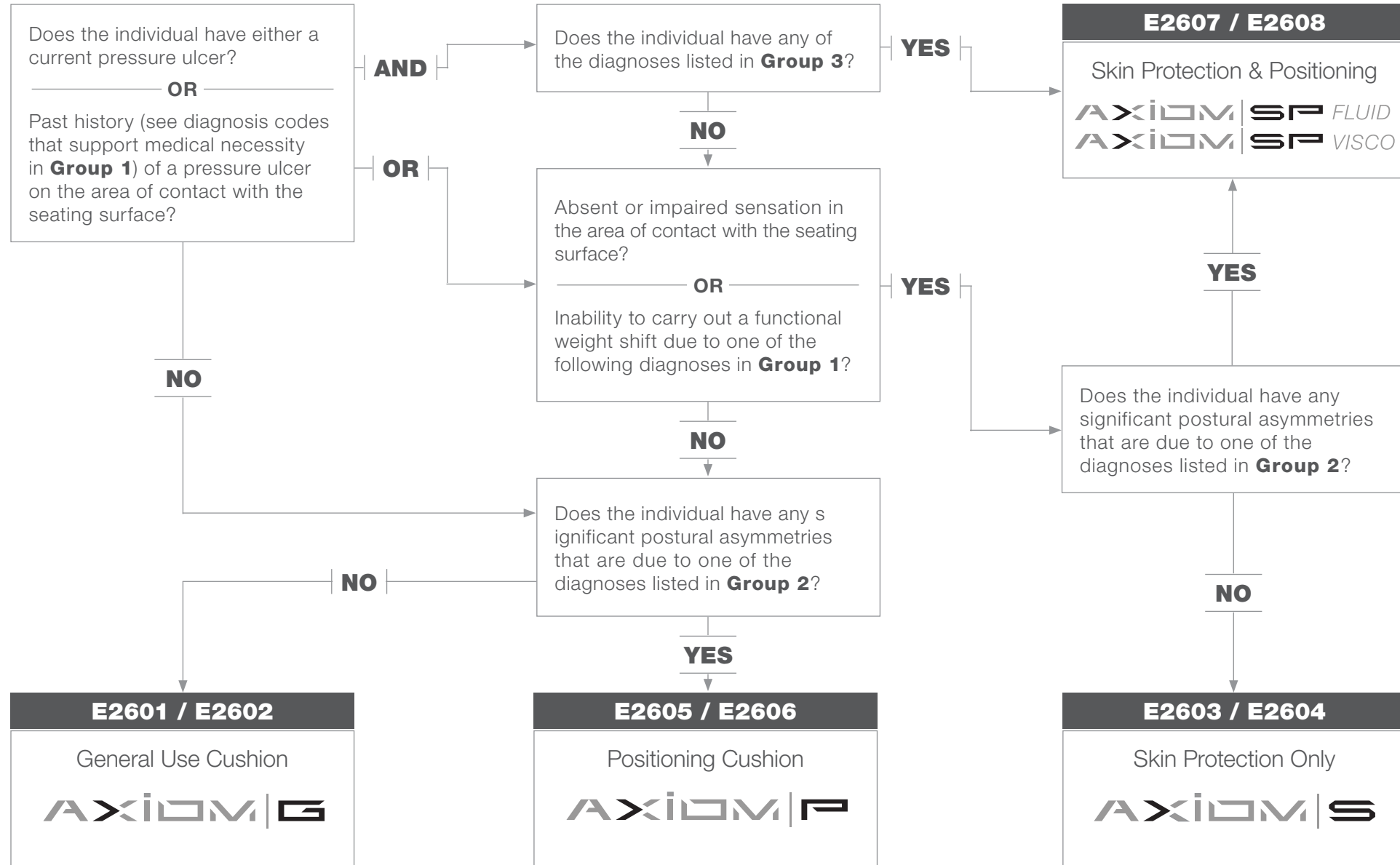


Axiom

MEDICARE COVERAGE GUIDELINES



To qualify for a wheelchair seat cushion, an individual must have a manual wheelchair or a power wheelchair with a sling/solid seat/back which meets Medicare coverage criteria along with a physician's prescription. In addition, the individual must meet the following criteria:
